

8 Days of Double Jackpot Official Rules

October 1 – October 8, 2017

1. To be eligible for promotions participants must be 21 years of age.
2. Participants must have a valid government issued ID.
3. Pacific Standard Time shall be the official time for all purposes of this Promotion.
4. This promotion is open to all valid Dragon Club members.
5. To be eligible participants must hit a jackpot on any reel slot machines.
